## Blockchain based Voting Platform (Consensoriented Oracel)

The rating of crowdsourced information plays a key role in the value chains and is becoming ever more important in every industry. SEVENS is the decentralized monitoring authority that uses swarm intelligence and a blockchain to verify statements.

7s.org is the first platform that rates crowdsourced information, such as news, events, videos, statements, contracts and insurances, and saves it in a decentralized blockchain.

The 7s platform also enables users to uncover „fake news“, discuss it on the basis of votes, spread their own opinions without censorship and emotionally reassess information.

This information can then be evaluated in a way that produces meaningful and useful results.

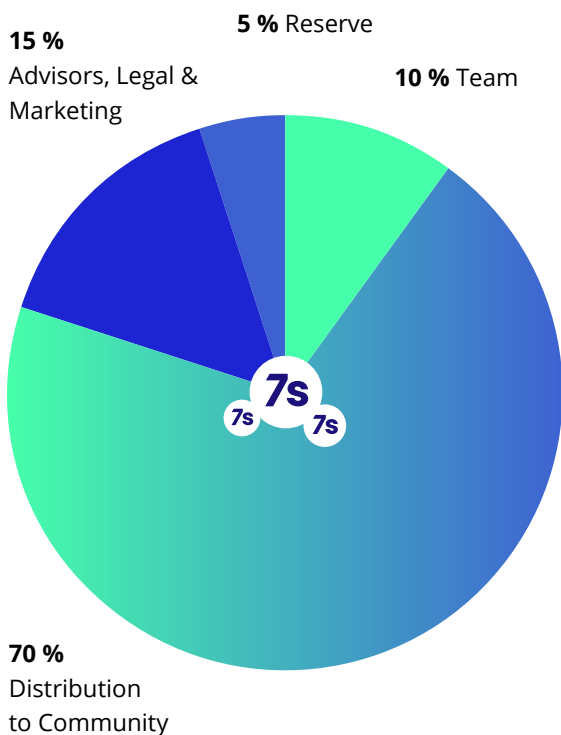

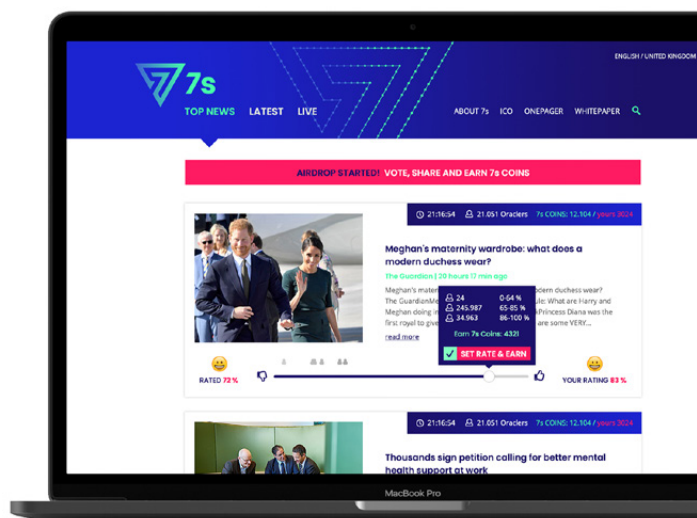
